- (1) **WOLVERHAMPTON CITY COUNCIL** of Civic Centre, St Peter's Square, Wolverhampton WV1 1RG (the "**Administering Authority**");

BACKGROUND

- (A) The Administering Authority is an administering authority within the meaning of the Regulations. It administers and maintains the Fund in accordance with the Regulations, and has the delegated function of making determinations under section 25(5) of the Public Service Pensions Act 2013 to allow employees of admission bodies to join the LGPS.
- (B) The Scheme Employer is a Scheme employer within the meaning of the Regulations.
- (C) The Administering Authority, the Scheme Employer and the Admission Body entered into an admission agreement dated [insert date] (the "**Admission Agreement**") pursuant to which the Admission Body was admitted to participate in the Fund with effect from [insert date].
- (D) The Admission Agreement referred to in recital (C) above needs to be amended to update the list of Eligible Employees in the Schedule to the Admission Agreement to include additional employees who transferred to and are employed by the Admission Body.
- (E) The Administering Authority, the Scheme Employer and the Admission Body have agreed to the terms of this addendum to the Admission Agreement to ensure that the Admission Agreement shall be amended in accordance with the terms of this Agreement.

NOW IT IS AGREED as follows:

1. **AMENDMENT**

1.1 The Administering Authority, the Scheme Employer and the Admission Body agree to amend the Admission Agreement on the basis that:

1.2 The Scheme Employer has executed this Agreement to show that it agrees to continue with the duties and responsibilities of the "Scheme Employer" under the Admission Agreement and under the Local Government Pension Scheme Regulations 2013.

2. **SEVERABILITY**

2.1 If any provision of this Agreement is found by any court, tribunal, administrative or regulatory body or authority of competent jurisdiction to be illegal, invalid or unenforceable then that provision will, to the extent required, be severed from this Agreement and will be ineffective, but (as far as is possible) without modifying any other provision of this Agreement, which will remain in full force and effect.

3. **COUNTERPARTS**

3.1 This Agreement may be executed in any number of counterparts, each of which will constitute an original, but which will together constitute one Agreement. This Agreement will not be effective until each party has executed at least one counterpart. The term "counterpart" includes a facsimile or scanned copy of this Agreement.

4. **RIGHTS OF THIRD PARTIES**

4.1 The parties do not intend that any term of this Agreement will be enforceable under the Contracts (Rights of Third Parties) Act 1999 by any person who is not a party to it.

5. **LAWS**

5.1 This Agreement and any non-contractual obligation arising out of or in connection with it will be governed by and interpreted in accordance with the laws of England and Wales, and the courts of England and Wales have exclusive jurisdiction to determine any dispute arising out of or in connection with this Agreement (including in relation to any non-contractual obligations).
