EOS at Federated Hermes

Over the last quarter we made voting recommendations at 304 meetings (3,483 resolutions). At 167 meetings we recommended opposing one or more resolutions. We recommended voting with management by exception at seven meetings and abstaining at one meeting. We supported management on all resolutions at the remaining 129 meetings.

Global

We made voting recommendations at 304 meetings (3,483 resolutions) over the last quarter.



- Total meetings in favour
- Meetings against (or against AND abstain) 54.9%
- Meetings abstained 0.3%
- Meetings with management by exception 2.3%

Australia & New Zealand

We made voting recommendations at 13 meetings (47 resolutions) over the last quarter.



- Total meetings in favour 30.8%
- Meetings against (or against AND abstain) 69.2%

Developed Asia

We made voting recommendations at 43 meetings (321 resolutions) over the last quarter.



- Total meetings in favour 65.1%
- Meetings against (or against AND abstain) 34.9%

Emerging & Developing Markets

We made voting recommendations at 85 meetings (759 resolutions) over the last guarter.



- Total meetings in favour 41.2%
- Meetings against (or against AND abstain) 56.5%
 - Meetings abstained 1.2%
 - Meetings with management by exception 1.2%

Europe

We made voting recommendations at 38 meetings (433 resolutions) over the last quarter.



- Total meetings in favour
- Meetings against (or against AND abstain) 60.5%
- Meetings with management by exception 5.3%

North America

We made voting recommendations at 26 meetings (320 resolutions) over the last quarter.



- Total meetings in favour 19.2%
- Meetings against (or against AND abstain) 69.2%
 Meetings with management
 - by exception 11.5%

United Kingdom

We made voting recommendations at 99 meetings (1,603 resolutions) over the last quarter.



- Total meetings in favour
- Meetings against (or against AND abstain) 54.5%
- Meetings with management by exception 1.0%


Global
